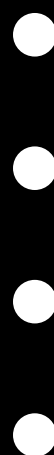

GARDEN EDUCATOR

The Garden Educator is a part-time position that offers support to students and the Santa Ana community.

This position will teach K-12 students about growing and using traditional plants and vegetables and serve as a resource for information to community gardeners.

- *Garden Educator Responsibilities:*
- *Hours of service are seasonal but, generally during the after-school program 3:00 p.m. to 6:00 p.m.*
- *Oversees and coordinates students' hands-on experiences in the garden (planting, tending, harvesting and cooking.)*
- *Manage the greenhouse garden and garden boxes, plan and prepare for garden work activities, manage planting schedule, ensure availability of tools and other necessary materials.*
- *Coordinate community garden events to bring students, families, and community members together.*
- *Consults with Keres language tutor and other staff.*
- *Submit a monthly invoice for services for services provided.*
- *Meet with the director/education program manager to discuss programming*

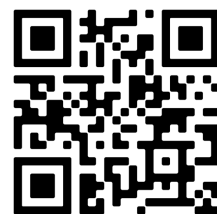

All media will be considered including, but not limited to, painting, sculpture, printmaking, clay, papier-mâché, photography, computer-generated, finger-painting, etc.

The exhibitor must be **aged 1 through 17**, and a **resident** of New Mexico.

The Process:

1. Refer the artist, along with the parent/guardian, to the curator, Martin Terry, at martinartstudios@gmail.com. **DEADLINE FOR REFERRALS IS – Friday, March 1, 2024.**
2. **Images of the work should be submitted at the same time.** Up to 8 works of art will be considered. All work must be solely by the artist. Images do not need to be professional quality; they can be taken from a cell phone.
3. If accepted, a commitment package, which includes rules and regulations will be sent. This document must be reviewed, signed, and returned as soon as possible. Dates, framing requirements, etc., will be included in the commitment package.
4. There are no fees for the referral, curatorial, or exhibit processes.
