The 2013 acquisition of the King's Brothers' Alamo Ranch by the Pueblo of Santa Ana marks a crucial step in the tribe's efforts to reclaim ancestral lands and assert its sovereignty. By pursuing acquired lands into trust, the tribe gains greater control over land use and environmental stewardship while enjoying tax benefits crucial for economic development. The King Alamo Ranch acquisition not only expands the tribe's land base but also strengthens its ability to protect sacred sites and uphold traditional lifestyles. As the Pueblo of Santa Ana continues to assert its sovereignty through land acquisitions, it paves the way for a more self-sufficient future.



#### Did you know?

Did you know that the Santa Ana Agricultural Enterprises (SAAE) consists of several different enterprises? The SAAE Director, Ryan Garcia oversees the following enterprises: Nursery, the Farm, the Blue Corn Mill and the Vineyard. Each of these ventures was created by the Santa Ana Tribal leaders to diversify available services, products, and income for the pueblo.



### Santa Ana Agricultural Enterprises **Spring Newsletter - April 2024**

- · The Nursery specializes in native and drought tolerant plants. This time of the year, the nursery is setting seedlings and starting annual vegetable and native plants for summer planting. Many of the plants we see in and around the administration offices and TWC were grown by the staff there. The Nursery Manager and can be reached at (505)-867-1323.
- · The Farm provides upon request services to tribal members such as field preparation, sowing and harvesting. The farm crew are currently working on irrigation canal cleanup, and field preparation for spring planting. We will start to irrigate the forage crops and then fertilize by May 10th. The Farm Foreman and can be reached at (505)-365-8055.
- · The Santa Ana Grain Mill offers high quality-certified organic varied milled grains. We have shopping retailers in: La Montanita, Bomivda Farms, and the Tiny Grocer. The crew is currently working on spring orders for local pueblos and tribes as far as Hopi in Arizona to provide blue corn grinds in fine and sprit varieties. The Mill Foreman and can be reached at (505)-771-6453.
- · The Vineyard grows grapes for Gruet winery which produces a Tamaya-specific blush sparkling wine. Currently the vineyard crew is completing pruning of the grapes. The grape vines will come out of the dormancy phase when the soil is above 58 degrees. The Vineyard Manager and can be reached at (505)-771-6789

### TRANSPORTATION DEPARTMENT







As the new Transportation Director, I will be overseeing Santa Ana's roadway construction and maintenance program, transit program, and applying for funding of transportation planning, construction, maintenance and transit programs.

My first task is to complete the intersection improvement at Dove Road and NM 313. The scope of the project is to widen pavement on NM 313, provide a new left turn lane from NM 313 to Dove Road and to reconstruct asphalt pavement on Eagle Lane and Dove Road turnouts. In addition, plans will address safety issues to include solar streetlight along the NM 313 corridor.



Other projects will include seeking funding for design and construction for Yellowbird Road and the Transfer Station, solar lighting at the Old Village and NM 550 intersections, reconstruction on the Old Village Road, new signs at the Old Village, and sidewalks in the Santa Ana area.

For the Fixed/On Demand Transit, Non-Emergency and Auxiliary Transport Services, we will continue to develop our transportation services as the community request increases.

As the Transportation Director, I will continue to work towards safer streets and transportation infrastructure as the pueblo grows. This will include supporting the Transportation Manager and Transit Staff as transit operation grows. #### Preparing for Garden Planting & Seed Starting 🦒

Summer garden planting is underway and preparing your garden is on top of your list! On March 8th & 9th we offered two seed starting workshops and had a total of 18 participants who started their seeds in trays. A variety of seed were planted: tomatoes, cucumbers, melons and of course chili. The trays will be cared for by the Tamaya Native Plant Nursery until they are ready to be planted in their garden space. Participants are always welcome to check on their seedlings.

Here are some tips for starting and planting your garden:

- Prep your garden space. Remove winter mulch, or if well composted, work into the top layer of the soil.
- Prepare the soil. Dig in plenty of compost. It takes work, but it improves the structure and fertility of the soil.
- Plan your space and group plants with similar growing conditions together. Plant tomatoes near squash because they are both warm-season vegetables with similar growing conditions.
- Start your seeds. Know which seeds will transplant and which won't. Starting your seeds indoors can help you get a jump on the growing season.
- Grow a variety of crops. Your garden is a great place to experiment with more than just a couple of vegetables. Squash, melon,





cucumbers, pumpkins, tomatoes, peppers, peas, and corn are all easy plants for beginners. Grow what you like to eat.

- Try to include at least one vegetable that's new to you. Discovery is half the fun while adding color to your garden and your plate.
- Prune. If you didn't prune or trim your fruit trees in the winter, prune before buds begin to break into bloom or you'll stress the tree resulting in a tiny crop or possibly no crop. Remember to clean your shears after cutting branches.



# Emergency Management







### **Emergency Management Updates:**

- Continuing development of Pueblo of Santa Ana Emergency Operations Plan (EOP) and Threat and Hazard Identification Risk Assessment (THIRA), with a focus on department-specific plans and annexes. A PSA Departmental Stakeholder Review meeting is being scheduled for late April.
- Developing a Pre-School Emergency Operations Plan (EOP) tailored for the Pre School/HeadStart Program's needs.
- Successfully completed the Tamaya Wellness Center Emergency Incident Action Plan and formulated the POSA Inclement Weather Operation Plan with input from PSA Department directors.
- Held a 2024 Primary/National Election Public Safety meeting for PSA Department stakeholders to discuss safety planning for TMC staff. The PSA OEM has secured a grant from the NM Department of Health for participation in the Cities Readiness Initiative (CRI), involving the development of a comprehensive Point of Distribution Plan (POD) specific to the Pueblo of Santa
- The Cities Readiness Initiative (CRI) aims to enhance preparedness and response capability in Bernalillo and Sandoval Counties, focusing on mass prophylaxis in the event of a chemical or biological attack. The initiative also aims to maximize the effectiveness of the Medical Countermeasure (MCM) for the Strategic National Stockpile (SNS).
- PSA OEM and PSA PD actively participated in the Sandoval County Election Board Public Safety Meeting to discuss emergency event planning for POSA and Tamaya Wellness Center voting sites during the 2024 Primary and National (Presidential) elections. Additionally, the POSA Mobile Incident Joint Command Center is fully operational and has been utilized for emergency/crisis events, critical incidents, and special events such as Feast Days and the Fireworks Show.



### **HIGH-SPEED INTERNET GRANT AWARD**

The Pueblo of Santa Ana was awarded a \$2.7 million dollar grant under the Connect New Mexico Pilot Program. The award will allow the Pueblo to bring broadband high-speed Internet to the Santa Ana community. The state-of-the-art fiber network will include 21 miles of new fiber optic cable and associated network components.

The Tamaya Housing Incorporated ("THI") is pleased to update the Pueblo of Santa Ana community on current status of the new housing subdivision. As we move into warmer weather we are planning to begin construction of homes. The infrastructure portion of the subdivision is at 95% complete. THI and its consultants, along with PSA tribal staff, conducted a final inspection of infrastructure (earthworks, roads, sidewalks, water and waste water systems) and provided an inspection report to the construction contractor, Kimo Constructors, of Bosque Farms, NM. THI is presently coordinating with gas and electric utilities to complete those systems.

Meanwhile, THI is preparing construction documents for the homes. The procurement for construction requires a competitive bidding phase and contract award phase prior to signing a construction contract with a home builder. The design of these homes will be similar to the current homes at Adobe Estates I (on Coral Lane and north Day School Road)

THI plans to start construction in June 2024. Homes will be complete approximately 8 to 10 months after construction starts depending on quantity. The homes will be built with financial assistance from the Pueblo of Santa Ana and the U.S. Department of Housing and Urban Development. THI is very excited to build quality, safe and sanitary homes for the community.

#### **UTILITY UPDATES:**

The Utilities Department has been working towards the goal of adding another Arsenic treatment plant on the westside water system. This will assure a safe and reliable supply for the Pueblo businesses. Funding for the design was procured from the State administered Tribal Infrastructure Fund. Preliminary design is complete, and the Pueblo has committed funds obtained through the American Rescue Plan to cover a portion of the construction. There is currently an application in to receive the balance of the estimated construction costs through the Tribal Infrastructure Fund. Assuming everything falls into place, construction could possibly start as soon as late summer.
